Terms and Conditions ("Agreement") between Seattle Korean Weddings ("Company") (collectively the "Parties") for Ko & Event services ("Agreement").  The Parties agree as follows:	
1. <b>Rental Items.</b> Company will make every reasonable effort to deliver the	_

Please note: Traditional Korean Hanboks must be worn underneath the Brides Korean Wedding Paebaek Hanbok. These are not included in the Standards Paebaek Package. The Traditional Korean Hanboks can be added to your rental package at an additional cost.

2. **Rental Terms**. The Client shall keep and maintain the rented equipment during the terms of the rental at their own cost and expense. They shall keep the equipment in the same state as when the item was first rented.

- All rental package prices are based on indoor usage. A 20% surcharge will be placed on all rentals that will be used outdoors, do to the additional wear and tear that occurs to the silk garments and rental items.
- The Client shall pay the Company full compensation for the replacement and/or repair of any equipment which is not returned because it is lost/stolen/damaged.
- Any item not returned in the same condition it was during the time of rental, will be charged according to the current updated price list of the items, The Company's invoice for replacement or repair is conclusive as to the amount Client shall pay under this paragraph for repair or replacement. Additional charges may be added to the order based on the level of changes. Please See Damage Addendum for up to date damage fees.
- All billing rates and rental service terms are based on the Scheduled Pick-Up and Delivery times. All rental rates are based on a 48 hour period, unless otherwise stated. If the items are not returned by the specified date and time, the Client will be subject to full term charges.
- 3. **Delivery & Self Pick-up.** The items shall be delivered to Client and returned to Company at the Client's risk, cost and expense of the Client until its return. Rental charges are billed to the RENTER for the full term even if the equipment is returned before the end of the term. If the equipment is not returned by the end of the term, then the rental charges shall continue on a full term basis for any additional term or portion thereof until the equipment is returned.
  - Client's who choose Self Pick-Up, are responsible for arriving on time and prepared with a vehicle large enough to safely transport the items. The Company recommends having at minimum, an empty mid-side SUV in order to safely transport all of the rental items.
  - On the scheduled delivery date, we will make every reasonable effort to deliver your order to the specified location by the time of day you have requested. Once your order has been delivered, we transfer the responsibility to you and your designated vendor or representative.
    - Delivery times are set and designated. Please insure that you have the location of the Ceremony set-up determined and prepared for on time delivery and set-up. Any delay may result in additional service fee of \$100 per hour. Hourly service charges will be charged on 30 minute increments.
- 4. **Rental Return.** The return of the rental items is the responsibility of the Client, unless otherwise arranged. Items are to be returned by the specified date and time on the contract. If the items are not returned by the specified date, the Client will be subject to full term charges. ALL RENTALS ARE FOR 48 HOURS, unless otherwise specified.

- 5. **Booking.** Availability and booking dates are not secured until a **NON REFUNABLE** deposit of 50% of the total estimated cost is received.
  - The deposit must be made within 5 days of expressed intention of booking, or the date will be re-opened to other inquires at the Company's discretion.
- 6. **Payment.** Clients are fully responsible and liable to pay all balances on their account.
  - 50% booking deposit, in the amount of \$\_\_\_\_\_ to be paid at the time of booking, and
  - Final 50% of remaining balance, in the amount of \$\_\_\_\_\_ to be paid 14 days prior to the wedding/event date on .
    - All payments made after 14 days are subject to a 10% late fee.
    - Payments made within 7 days of the event date are subject to a 15% late fee.
- 7. Cancellations and Refunds. Deposits and all other initial payments secures a minimum number of hours in The Company's calendar to The Clients event. Due to the specialized nature of our work, our acceptance of your order dictates that we must decline additional inquiry's that we receive for that week. Due to these factors, all deposits made, up to 50% of the initial estimate total, is **NON REFUNDABLE**.
  - In the event of an order/event cancellation, the 50% deposit made to reserve the date will be forfeited.
  - In the event of a change in date or change in circumstance, The Company will transfer the remaining balance and deposit to the new requested date, subject to date availability.
    - 25% of the remaining balance is due on the original final balance due date, with the remaining 25% due 14 days prior to the new event date.
  - Once the final balance has been paid, 14 days prior to the event, no money will be refunded or credited if the order is cancelled.
  - The first rescheduling will be complimentary and no change of date fees will be applied. Additional change of dates, will be subject to a 10% fee.
- 8. **Image Disclosure**. The Company customarily takes photos of each set-up at the delivery site for business purposes. The Company may also submit images of your images to publication in magazines or to other media. The Company reserves the right to use photos and statements from clients in portfolios and/or on our website.
- 10. **Limitation of Liability.** In the event that a catastrophic occurrence such as death, fire, earthquake, natural disaster, or other Act of God beyond the Company's control, which prevents our performance, we will make every reasonable effort to ensure that your rental items will be produced and delivered on the scheduled delivery date and time with a suitable substitute. However, in the event your item is not delivered despite our best efforts when a catastrophic event occurs, the limit of The Company's liability for such non-performance will be to make a

full refund of all monies the Client has paid. Company will not be liable for any additional or consequential damages.

Client agrees to hold the Company, entirely free from any liability, including financial responsibility for damages, injuries, or illness incurred.
